**ORDINANCE NO. 1 OF 2019**

**CITY OF MONONGAHELA, COUNTY OF WASHINGTON, COMMONWEALTH OF PENNSYLVANIA**

**AN ORDINANCE OF THE CITY OF MONONGAHELA, COUNTY OF WASHINGTON, COMMONWEALTH OF PENNSYLVANIA AUTHORIZING THE IMPLEMENTATION OF A MUNICIPAL RECYCLING PROGRAM AND REGULATING AND PROHIBITING THE DISPOSAL OF LEAF WASTE**

WHEREAS, the City of Monongahela is a body corporate and politic, and a duly recognized City of the Third Class of the Commonwealth of Pennsylvania; and

WHEREAS, the City Council of Monongahela is authorized pursuant to the Third Class City Code to regulate and legislate concerning the public welfare of the citizens and residents of the City; and

WHEREAS, pursuant to Ordinance Nos. 1 of 1992, 2 of 1992, and 4 of 1995 the City currently regulates the production, collection, and hauling of waste, municipal waste, and rubbish within the City; and

WHEREAS, the City desires to further regulate and ordain concerning the collection and hauling of certain recyclable materials and yard waste.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the City Council of the City of Monongahela, County of Washington, Commonwealth of Pennsylvania, that the City of Monongahela Ordinance Nos. 1 of 1992, 2 of 1992, and 4 of 1995 are hereby amended, to wit:

Section 1. Definitions. The following words and phrases shall be added to Ordinance Nos. 1 of 1992, 2 of 1992, and 4 of 1995 and shall have the meaning ascribed herein, unless the context of this Ordinance indicates a different meaning:

(a) The definitions of the terms AVERAGE DAILY VOLUME, DEGRADABLE PLASTIC BEVERAGE CARRIER, MUNICIPAL RECYCLING PROGRAM, PLASTIC BEVERAGE CARRIER, POSTCONSUMER MATERIAL, PROCESSING, RECYCLED CONTENT, RECYCLING, RECYCLING FACILITY, and WASTE REDUCTION as they are so defined in Section 103 of Act 101 of 1988 known as the "Municipal Waste Planning, Recycling and Waste Reduction Act" shall be adopted as the same meanings and definitions herein.

(b) The definitions of "Leaf Waste" and "Recycling" as contained in Ordinance Nos. 1 of 1992, 2 of 1992, and 4 of 1995 are hereby repealed, as ascribed the same
