**CITY OF MONONGAHELA, COUNTY OF WASHINGTON, COMMONWEALTH OF PENNSYLVANIA**

**AN ORDINANCE AMENDING ORDINANCE NO. 5 – 2019, REGARDING SALARIES OF CITY EMPLOYEES**

WHEREAS, the City of Monongahela is a body corporate and politic, and a duly recognized City of the Third Class of the Commonwealth of Pennsylvania; and

WHEREAS, the Council of the City of Monongahela has heretofore adopted Ordinance No. 5 of 2019, setting the salaries of certain city employees for calendar and fiscal year 2020 (hereinafter, the “Salary Ordinance”); and

WHEREAS, due to changes in the status of certain personnel, the Council of the City of Monongahela desires to amend the Salary Ordinance.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the City of Monongahela, Washington County, Pennsylvania that the Salary Ordinance, Ordinance No. 5 of 2019, is here by amended in part as follows, and therefore amends and revises the compensation payable to the within named officers and employees of the City of Monongahela, Washington County, Pennsylvania as follows:

**Section 1.** Section II of the Salary Ordinance, governing the salaries of the several officers and employees within the Department of Accounts and Finance, shall be amended as follows:

(a) The City Clerk shall receive a salary of the sum of [~~\$42,000.00~~] \$42,400.00 per annum, which shall be payable in equal portions biweekly, at the same time as the payroll for such period is payable.

(b) The Office Assistant shall receive a salary of the sum of [~~\$37,673.00~~] \$15,000.00 per annum, which shall be payable in equal portions biweekly, at the same time as the payroll for such period is payable.

(e) The salary of the Deputy Tax Collector, employed by the City Treasurer, as Tax Collector, shall receive a salary of the sum of [~~\$30,338.00~~] \$26,250.00, per annum, which

shall be payable in equal portions biweekly, at the same time as the payroll for such period is payable.

**Section 2.** This Ordinance, and the amendments contained herein to the Salary Ordinance, shall take effect immediately upon enactment and signature of the Mayor.

**Section 3.** Upon taking effect, the amendments contained herein to the Salary Ordinance shall furthermore be applied retroactively back to January 8, 2020.

**Section 4.** If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any remaining provisions, sentences, clauses, sections, or parts of this Ordinance. It is hereby declared as the intent of the City Council that such remainder shall be and shall remain in full force and effect.

**Section 5.** All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed insofar, but only insofar, as the same are inconsistent herewith.
